<ul style="list-style-type: none"><li>• Provide a safe, secure and caring learning environment;</li><li>• Teach and encourage the children to do their best and achieve their full potential as a valued member of the school community;</li><li>• Develop in each child positive values and a caring attitude towards the school community and the environment;</li><li>• Provide a balanced curriculum of the highest quality and meet the individual needs of every child;</li><li>• provide opportunities to enable all children to take part in all activities;</li><li>• Set regular home learning and to mark it if appropriate;</li><li>• Inform children and parents/carers what the teachers aim to teach the children each term;</li></ul>	<ul style="list-style-type: none"><li>• See that my child attends school regularly, is punctual and properly equipped and ready to learn;</li><li>• Inform the school on the first day of absence;</li><li>• Raise any concerns or problems that might affect my child's ability to learn or behave appropriately;</li><li>• Support the school's behaviour policy, to make sure my child maintains good behaviour;</li><li>• Support and model the school's policies and expectations.</li><li>• Support my child with homework and other home learning opportunities and listen to my child read daily;</li><li>• Attend parent consultations with the teacher to discuss my child's achievements and progress;</li></ul>	<ul style="list-style-type: none"><li>• Learn; this includes doing my best with remote learning when necessary.</li><li>• Work hard and listen carefully to instructions;</li><li>• Come to school regularly and on time;</li><li>• Follow the school and class rules;</li><li>• Behave well at all times to maintain the safety of myself and others;</li><li>• Be polite, friendly and helpful to other children and all adults;</li><li>• Tell somebody if there is something I am not happy about;</li><li>• Do my home learning regularly and return it to school on time;</li><li>• Bring all the equipment I need every day including my PE kit, book bag and reading books;</li><li>• Take good care of the school environment and living things.</li></ul>

<ul style="list-style-type: none"> <li>• Be welcoming and offer opportunities for parents/carers to become involved in the daily life of the school;</li> <li>• Contact parents/carers as soon as concerns are raised about your child's work, behaviour, health, attendance or punctuality;</li> <li>• Have a clear and consistent approach to rewards and consequences for children as set out in the Behaviour Policy;</li> <li>• Communicate between home and school through notices, newsletters, website, emails, social media and general meetings.</li> <li>• Listen to parental concerns about their children and respond appropriately.</li> <li>• Taking into account the COVID-19 pandemic, provide a safe school / learning environment and remote learning opportunities, where required.</li> </ul>	<ul style="list-style-type: none"> <li>• Support all staff in their efforts to create a caring community which values children and their rights;</li> <li>• Support the school in getting any help my child may need;</li> <li>• Read all letters/messages/emails that are sent home;</li> <li>• Inform the school immediately of any changes to parents/carer and emergency contacts details.</li> <li>• To help my child understand that everyone is of equal importance;</li> <li>• To encourage my child to appreciate and respect the views, beliefs and religions of others.</li> <li>• Discuss the Acceptable Use Agreement / eSafety Rules set out below, and agree to follow them.</li> <li>• In light of COVID-19, adhere to the school's procedures and expectations and support my child with remote learning, where required.</li> </ul>	<ul style="list-style-type: none"> <li>• Agree to follow the Acceptable Use Agreement / eSafety Rules set out below.</li> </ul>

## **Acceptable Use Agreement / eSafety Rules for Primary Pupils**

- I will only use ICT in school for school purposes
- I will only use my class e-mail address or my own school e-mail address when e-mailing
- I will only open e-mail attachments from people I know, or who my teacher has approved
- I will not tell other people my ICT passwords
- I will only open/delete my own files
- I will make sure that all ICT contact with other children and adults is responsible, polite and sensible
- I will not deliberately look for, save or send anything that could be unpleasant or nasty. If I accidentally find anything like this I will tell my teacher immediately
- I will not give out my own/others' details such as name, phone number or home address. I will not arrange to meet someone or send my image unless this is part of a school project approved by my teacher and a responsible adult comes with me
- I will be responsible for my behaviour when using ICT because I know that these rules are to keep me safe
- I will support the school approach to online safety and not deliberately upload or add any images, video, sounds or text that could upset any member of the school community
- I will follow the school's rules and expectations when engaging in remote learning.
- I know that my use of ICT can be checked and my parent/carer contacted if a member of school staff is concerned about my safety
- I will not sign up for any online service unless this is an agreed part of a school project approved by my teacher

ICT including the internet, e-mail and mobile technologies has become an important part of learning in our school. We expect all children to be safe and responsible when using any ICT.
